The Council has had considerable discussion on budget expenditures and projects and determined a rate increase of 2%. Rate income continues to be below the 10-year plan.

The total budgeted rate income for 2021/2022 is \$2,988,225, compared to the budgeted rate income of \$2,817,722 in 2020/21.

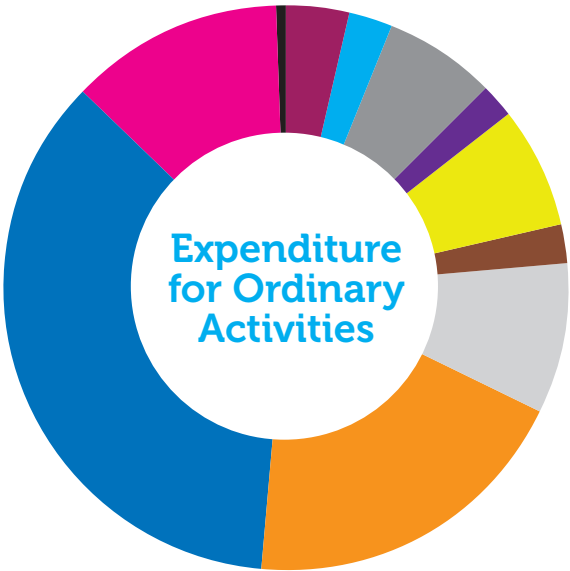

Significant Projects

Perenjori Pavilion Upgrade

An upgrade to the Change Rooms at the Pavilion will be completed in the 2021/2022 financial year and be a significant improvement on current facilities. Also included in this Pavilion upgrade is purchase of a generator to allow for the venue to be used as a functional evacuation centre in the case of any future natural disasters.

Tourist Shelters

Upgrades to tourist sites will be implemented with the installation of shelters over existing picnic tables and seating at tourist sites such as Camel Soak, Latham Recreation Centre and Maya, along with shaded seating alongside the Village Green.

Shire Housing

Council is committed to maintaining quality housing stock and have made Budget allocation for the construction of a two-bedroom, two-bathroom dwelling within the Perenjori townsite.

Caravan Park Accommodation

The growth in tourism and mining activity has significantly increased the demand for quality self-contained accommodation in Perenjori. A low-interest loan from the WA Treasury of \$500,000 will enable the construction of new Chalets at the Caravan Park to retain visitors in town which in turn benefits the local economy.

Grocery Store

Capital expenditure of \$800,000 from the Mt Gibson Infrastructure Fund has been allocated in the Budget for development of a purpose-built grocery store.

Road Program

Council reviews its road network each year by carrying out road inspections. The roads program for 2021-2022 has been developed at a total cost of \$3,373,357 and is funded by:

Reserve Funds

The estimated Reserve Funds balance as at 30th June 2022 is \$2,703,985. The decrease in reserve funds is due to funding required to secure a community shop, plant replacement and new computer hardware and software for administration.

Borrowings

The 2021-2022 budget makes provision for a new loan to the value of \$500,000 with Council looking to acquire 2 x two-bedroom chalets to be situated at the Caravan Park. Council will also be contributing its own source funding for the purchase of these new chalets.

Rates Charges and Instalments

A 2% rate increase across all the Shire rating categories has been included in the budget for this financial year. Any reduction and or increase in the annual charges (other than the 2% applied by Council) will be due to movement in your property valuation provided by the Valuer General's Office.

The 10% discount for rates paid by 11th October 2021 continues to apply. No further discounts apply. The discount does not apply to properties that are on minimum rates.

Overdue interest will accrue daily at 7% per annum from 11th October 2021 for current rates and charges. Overdue interest will accrue daily at 7% per annum from 1st July 2021 on arrears. Debt collection will occur on all outstanding and overdue rates and charges.

Ratepayers may also choose to pay their rates through four instalments. No discounts apply to rates paid by instalments.

1st Instalment	11th October 2021
2nd Instalment	13th December 2021
3rd Instalment	14th February 2022
4th Instalment	19th April 2022

An administration fee is charged for assessments choosing to pay via instalments.

Pet Registrations

Dog Registrations

Registration and micro-chipping costs are set by the State Government.

Dogs over 3 months of age must be registered. Dog registrations expire on the 31st October each year. Registration may be for a 1 or 3 year period or for life.

Cat Registrations

Registration and micro-chipping costs are set by the State Government. Cats over 6 months of age must be registered.

Applications for approval for a breeding cat must be sought from the Shire of Perenjori.

Eligible pensioners/seniors receive a 50% discount on dog and cat fees. If you are claiming dog or cat sterilisation fees, a sterilisation certificate must be presented upon registration.



Fire Safety

Prohibited Burning Period

1st November to 14th February

STRICTLY NO BURNING

Restricted Burning Period

17th September to 31st October

15th February to 15th March

PERMITS ARE REQUIRED

Fire Control Officers are not obliged to issue permits. Permits cannot be issued over the phone and should a Fire Control Officer refuse to issue a permit, it is a breach of the Bush Fires Act 1954 to request a permit from another Fire Control.

Fire Break Notice

Section 33 B F A

First and final notice is hereby served to all residents and ratepayers. Failure to install and maintain firebreaks in accordance with this notice may result in a \$5,000 fine.



Fire Break Guide

Tree plantations of more than 3 hectares but less than 10 hectares

Construct a 10m wide mineral earth firebreak with a vertical clearance of 4m high; clear of all inflammable material immediately surrounding the plantation (adjacent areas of the same property subject to provisions as for rural land)

Plantations larger than 10 hectares

Must comply with the Code of Practice for Timber Plantations in the Western Australia Guideline for Plantation Fire Protection. A copy is available from the Shire of Perenjori upon request.

Penalties

Offence relating to lighting a fire in the open air	\$250

Failure of Occupier to extinguish a bushfire	\$250
Refusal to state name and abode or stating a false name and abode	\$100

Bush Fires Act 1954 As Amended

Notice is hereby given to all landowners/occupiers within the Shire of Perenjori that fire-breaks must be installed on or by 1st October and flammable material maintained up to and including 15th March as per the requirements of Section 33 of the Bush Fires Act 1954.

PROPERTIES WILL BE INSPECTED TO ENSURE THEY COMPLY WITH COUNCILS REQUIREMENTS.

1. Townsites

On or before 1st October all town lots within the town sites of Perenjori, Bowgada, Bunjil, Caron, Latham and Maya are required to be treated as follows. Where the area of land is less than 3,000m², the property must be cleared, mowed, slashed to a MAXIMUM height of 4.5 cm of all flammable material.

Where the area of the land is 3,000m² or more, a firebreak must be provided not less than 3 metres in width inside and along the whole of the external boundaries of the properties owned or occupied and all flammable material must be cleared to a 3m distance from all buildings and/or haystacks situated on the land and maintained free of such material until the 15th March.

2. Fuel Pumps (fuel storage sites)

On or before the 1st October all grass and similar material is to be cleared from such places where fuel is stored/ located and where drums, empty or full, are stored and such areas to be maintained cleared of grass and similar flammable material until 15th March.

3. Farm Buildings and Unattended Electric Motors and Hay Stacks

Fire breaks to be at least 3 metres in width completely surrounding and not more than 20 metres from the perimeter of any building, group of buildings or haystacks,. All flammable material must be removed from an area 3



metres in width immediately surrounding the building. All flammable material must be removed from an area 3 metres in width immediately surrounding an unattended electric motor site.

4. Unattended Fuel Operated Motors

All flammable material must be removed from an area 3 metres in width immediately surrounding an unattended fuel operated motor whether the motor is intended to be used or not.

5. Rural Land

Firebreaks must be provided not less than 3 metres in width inside and along the whole of the external boundaries of the properties owned or occupied. Where this is not practicable the firebreaks must be provided as near as possible to, and within, such boundaries.

6. Barbeques and Incinerators

Gas and electric barbeques are permitted any time. Solid fuel barbeques and incinerators are PROHIBITED on days of VERY HIGH FIRE DANGER or above.

7. Penalty

The penalty for failing to comply with this notice is a fine of up to \$400 and a person in default is also liable, whether prosecuted or not, to pay the cost of performing the work in this notice, if it is not carried out by the owner or Occupier by the date required by this notice.

Harvesting Operations

1. Harvesting operations are not permitted on Christmas Day, Boxing Day and New Years Day. A separate fire fighting fire appliance is required to be present anywhere that harvesting, chaining, raking stubble, straw baling and associated allied activities are undertaken during restricted and prohibited periods. The fire fighting unit must be in a state of readiness and have a minimum capacity of 400 litres of water, a powered pump and hose. The farm fire fighting unit should be parked on bare ground in or near the harvesting or working area.
2. A Harvesting and Movement and Use of Internal Combustion Engines ban (except for the watering and movement of stock) will be imposed when the actual weather conditions reach a Fire Danger Index rating of 35 or above for the weather stations of two Bush Fire Control Officers. All such bans are at the discretion of the Chief Bush Fire Control Officer or a Duly Appointed person.
