Council Roles

Advocacy:

When Council advocates on its own behalf or on behalf of its community to another level of government /body /agency.

Executive/Strategic:

The substantial direction setting and oversight role of the Council e.g. Adopting plans and reports, accepting tenders, directing operations, setting and amending budgets.

Legislative:

Includes adopting local laws, town planning schemes and policies.

Review:

When Council reviews decisions made by Officers.

Quasi-Judicial:

When Council determines an application/matter that directly affects a person's rights and interests. The Judicial character arises from the obligations to abide by the principles of natural justice.

Examples of Quasi-Judicial authority include town planning applications, building licences, applications for other permits/licences (e.g.: under Health Act, Dog Act or Local Laws) and other decisions that may be appealable to the State Administrative Tribunal.

Summary

This item seeks Council consideration on the route determination request received by Main Roads on behalf of NewHaul/Fenix Resources.

Background

The Shire of Perenjori received correspondence on the 19 September 2023 from Main Roads Heavy Vehicle Services (HVS) on behalf of NewHaul/Fenix Resources. The submission requested comment to add roads onto the Performance Based Standards (PBS) network specifically for the following roads:

The request is for Road No. 5140015 (Perenjori Rothsay Road) and the length of the Perenjori Rail Siding to be amended to 15.21 klm at SLK 2.59, which is where vehicles would access the rail head.

It is understood that NewHaul, on behalf of Fenix Resources, has requested to utilise 60-meter PBS quads from Extension Hill to the Perenjori Rail Siding via Wannara Road and Perenjori Rothsay Road.

Due to the high cost of carting via rail, it is believed that NewHaul will utilise AB Triple Road train combinations, with a length of approximately 36.5 metres and a gross mass of 118 tonne, from the Perenjori Rail Siding to the Geraldton Port for a 6-month trial period.

The latest advice is that 110,000 tonnes of material is proposed to be carted, per month, for the first 6 months. This equates to roughly 850 movements one way between Extension Hill Mine Site and the rail siding on the Perenjori-Rothsay Road.

On the assumption that the AB Triple Road train configuration is utilised to transport the material to Geraldton, approximately 1450 loads one way, per month, would be required.

Officer Comment

The request for the individual access 60-meter quad road train on Council roads in isolation appears reasonable and in line with requests that council has previously considered. The utilisation of the vehicles on the Performance Based network system requires an improved standard of safety of the vehicle and less vehicle movement required to transport the loads.

A draft road user agreement is being developed for the use of the road by the proponents but is yet to be finalised and agreed upon due to change of vehicles, differing proponents and route variations, however any consideration of approvals and road agreements will be contingent upon the proponents having full responsibility to maintain the road to an agreed standard.

As Council is aware, the main concern with the commencement of operations at the Extension Hill Minesite is the proposal not to utilise the rail freight and to instead transport the material direct from the mine site to the Geraldton Port, utilising the Wubin-Mullewa Highway and other connecting routes. This proposal will significantly increase the road train vehicle movements on the Wubin-Mullewa Highway through the Perenjori, Morawa and Mingenew Shires and townsites.

Whilst the potential haulage route enters Main Road's jurisdiction on the Wubin-Mullewa Highway through Perenjori and then through the Shires of Morawa and Mingenew to Geraldton, it is in Council's interest to be well informed of any potential issues that may directly impact the townsite.

The Shire President has been in discussions with representatives of Main Roads regarding the concerns and impacts upon communities, in regard to the utilisation of road freight when there is the option to utilise the rail freight, and will continue to elevate this issue to the relevant Government Ministers.
