## Council Roles

### **Advocacy:**

When Council advocates on its own behalf or on behalf of its community to another level of government /body /agency.

### **Executive/Strategic:**

The substantial direction setting and oversight role of the Council e.g., Adopting plans and reports, accepting tenders, directing operations, setting and amending budgets.

### **Legislative:**

Includes adopting local laws, town planning schemes and policies.

### **Review:**

When Council reviews decisions made by Officers.

### **Quasi-Judicial:**

When Council determines an application/matter that directly affects a person's rights and interests. The Judicial character arises from the obligations to abide by the principles of natural justice.

Examples of Quasi-Judicial authority include town planning applications, building licences, applications for other permits/licences (e.g.: under Health Act, Dog Act or Local Laws) and other decisions that may be appealable to the State Administrative Tribunal.

#### **Summary**

This item requests Council to appoint a Presiding Member and Deputy Presiding Member of the Audit, Risk and Improvement Committee (ARIC) in accordance with amendments to Section 5.2 of the *Local Government Act 1995*.

#### **Background**

At the October 2025 Special Council Meeting, Council appointed all Elected Members as members of the Audit Committee. Amendments to Section 5.12 of the *Local Government Act 1995* requires Councils to appoint new Audit, Risk and Improvement Committee Presiding Member and a Deputy to the Presiding Member. This is opposed to the previous arrangement where the Audit Committee itself appointed the Presiding Member and Deputy Presiding Member. These appointments must be made by an Absolute Majority decision of Council from this point forward.

Therefore, Council must formally appoint the Presiding Member and Deputy Presiding Member, by absolute majority, prior to the December 2025 Audit, Risk and Improvement Committee.

#### **Statutory Environment**

##### *Local Government Act 1995*

###### 5.12. Presiding members and deputies

(1) The local government must appoint\* a member of a committee to be the presiding member of the committee.

\* Absolute majority required.

(2) The local government may appoint\* a member of a committee to be the deputy presiding member of the committee.

\* Absolute majority required.
